The institute has a total strength of about 400 trainees and **18** staff members. The hostel has strength of approximately **56 female trainees** (the strength of trainees may increase/decrease). Items of Tea, Coffee, Snacks, Cold drinks and lunch shall be supplied by the contractor to the trainees and staff of the Institute on item rate basis in the canteen. Breakfast, Lunch and Dinner shall be supplied by the contractor to the hosteller per trainee per month basis in the hostel mess.

(B) For Canteen


